Standard Membership – applies to one league. Spare fees must be paid if sparing in another league. Practice ice when available is \$10.00 per session.

Premium Membership – unlimited curling in multiple leagues, practice ice (subject to availability), sparing and clinics.

Easy Payment Plan: Total fees plus \$10.00 handling fee – payable in 4 equal payments. Due: September 15, October 14, November 18, and December 16, 2021.

All fees not on the payment plan must be paid in full by October 31, 2021 – a \$25.00 penalty will be applied to outstanding memberships.

Refund Procedure:

1. The refund policy will apply to all members, regardless of age group or curling league.
2. In the event of an injury or illness that results in the member’s inability to continue to curl, the refund will be based on a prorata basis. Documentation may be required. After January 1st, requests will be considered but as a credit toward the next season.
3. In the event that the member has moved and is unable to curl, the refund will be on a prorata basis. Refund requests will only be considered up to December 31st.
4. NOCA dues will be considered fully earned and non refundable.
5. Refunds will be considered for requests other than illness/injury (b) or move (c), only up to 30 days from the start of the season.
6. Refund request must be a written request to the Board. An email will be considered a written request.
