Details

- **FULL TEAM ENTRIES PREFERRED.**
- All Rates apply to Evening and/or Day Leagues include HST and NOCA Association Fees
- **Standard Fee** – applies to one League. Spare Fee applies if sparing in another League. Practice Ice Fee applies
- **Premium Fee** – unlimited Curling in multiple Leagues. Practice Ice at no charge, (subject to availability)
- **Easy Payment Plan:** Total fees plus \$20.00 handling fee – payable in 4 equal payments. Due: Registration night, October 15, November 18 and December 9, 2024
Please note the \$50.00 fundraising fee is to be paid in full with first payment.
- **All fees must be paid in full by October 31, 2024 – a \$50.00 penalty will be applied to outstanding curling fees. (Exception those who have opted for the payment plan)**
- **There will also be a \$50.00 Club Fundraising fee for each membership – this will be paid with Membership (Now one payment! Not included in the rates above).**

REFUND PROCEDURE:

1. The refund process will apply to all members, regardless of age, group or curling league.
2. In the event of an injury or illness that results in the member's inability to continue to curl, the refund will be on a prorated basis. Documentation may be required. After January 1st, requests will be considered but as a credit to the next season.
3. In the event that the member has moved and is unable to curl, the refund will be on a prorated basis. Refund requests will only be considered up to December 31st.
4. NOCA dues will be considered fully earned and non-refundable.
5. Refunds will be considered for requests other than illness or injury (b) move, (c) only up to 30 days from the start of the season.
6. Refund requests must be submitted in writing to the Board, An email will be considered as a written request.
7. A \$30.00 administration fee will apply.
