

CURL FORT FRANCES COMMUNITY CENTRE MEMBERSHIP RATES

2026-2027 Curling Season

All Rates apply to Evening or Day Leagues - include HST and NOCA association fees

Standard Membership – applies to one league. Spare fees must be paid if sparing in another league. Practice ice when available is \$20.00 per session.

Premium Membership – unlimited curling in multiple leagues, practice ice (subject to availability), sparing and clinics.

Full Season:

Standard Membership – 1 League	\$440.00
Premium Membership – unlimited curling	\$655.00
5 th and/or 6 th Player on a team (each)- Standard membership applies	\$195.00

Half Season: Oct to Dec or Jan- Apr

Standard Membership - 1 League	\$230.00
Premium Membership - unlimited curling	\$340.00
5 th or 6 th player on each team - Standard membership applies	\$125.00

(If one member is playing the first half of the season and another the second half of the season they each pay the half season rate.)

U12, U15 U18 Tuesday & Friday 4:00-5:30 \$375.00 includes practice, league and NOCA U18 and U21 Registration fees AND \$100 volunteer deposit – 6 hours of volunteer time required from each participant.

U12 and U15 Friday Only \$300.00 same additional requirements as Tuesday and Friday

Each family with participants in the U9, U12, U15 and U18 Program will be required to sell one book of raffle tickets. Additional books are available.

Spare Fee \$15.00 per game – no cap
(Spare fees to be paid prior to accessing the ice, along with the completion of the Curl Fort Frances participation waiver form)

All fees must be paid in full by October 31, 2026 – a \$50.00 penalty will be applied to outstanding memberships. (Exception those who have opted for the payment plan)

REFUND PROCEDURE:

1. The refund process will apply to all members, regardless of age, group or curling league.
2. In the event of an injury or illness that results in the member's inability to continue to curl, the refund will be on a prorated basis. Documentation may be required. After January 1st, requests will be considered but as a credit to the next season.
3. In the event that the member has moved and is unable to curl, the refund will be on a prorated basis. Refund requests will only be considered up to December 31st.
4. NOCA dues will be considered fully earned and non-refundable.
5. Refunds will be considered for requests other than illness or injury (b) move, (c) only up to 30 days from the start of the season.
6. Refund requests must be submitted in writing to the Board, An email will be considered as a written request.
7. A \$30.00 administration fee will apply.
